These Terms and Conditions apply to the climate change data services provided by Susteer AB.

#### **Definitions**

- "Data" means meteorological, environmental, hydrological or oceanographic data (whether historical or otherwise) provided (in whatever medium) as part of the Services.
- 2. "Fees" means in the sums payable by you to us and, in respect of the Services, either the amount posted on the Website or as otherwise notified to you when you place the Order, in each case together with all taxes and duties at the rate prevailing at the date the Services (or relevant part) are provided.
- 3. "Intellectual Property Rights" means any intellectual property right including but not limited to copyright, moral right, database right, patent, trade mark, domain name, trade secret or design right (whether registered or unregistered) or where relevant any application for any such rights in any jurisdiction.
- 4. "Order" means your request for us to deliver the Services whether verbally or in writing and whether electronically or otherwise.
- 5. "Services" means the services that we provide to you pursuant to an Order comprising the provision of extracted and pre-processed climate change data.

#### The Services

- 6. These Terms and Conditions apply to the climate change data services ("the Services") provided by Susteer AB.
- 7. The Services are to extract climate change data from the CMIP6 archive relevant for a specific location detailed by the customer and to pre-process the data into a user-friendly comma separated version (.csv) format. The climate change datasets that can be extracted are as listed in the Order Form.
- 8. Data is supplied without correction. The CMIP6 archive contains the output of scientific simulations of the past and potential future that are subject to multiple sources of error, ranging from errors in data handling, to errors in the representation of the real world in either the model, or the experimental setup for which the model was used. Different parts of the CMIP6 archive may be subject to differing levels of such errors, and users should be alert to these issues, and their potential consequences (and to the limitations of liability expressed in the data license).
- 9. The data supplied by Susteer AB is not to be resold to any third party or used for any other purposes other than the project named in the Order form.

### The Fees

- 10. We will not be obliged to supply you with any Services until you have paid us the Fees in full.
- 11. Invoices will be issued in Swedish Kroner (SEK).
- 12. You acknowledge that you will retain the risk of exchange rate fluctuations for all payments made in approved foreign currencies.

### Acceptance of Terms

- 13. By using the Services you agree to be legally bound by these Terms and Conditions, which take effect immediately on your first use of the Services.

This Privacy Policy lets you know about our policies for the collection and use of information about you.

#### **Introducing Susteer AB**

Susteer ("us", "we", or "our") is a data supported consultancy in environmental management and sustainability.

We are the Data Controller for the purposes of the General Data Protection Regulation. As a data controller we have a responsibility to make sure you know why and how your personal information is being collected in accordance with relevant data protection law in connection with any personal information collected or received by us arising from your use of any of our products, services, applications, websites and customer support communications.

Susteer will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

### **Sharing your data**

Susteer may disclose your Personal Data in the good faith belief that such action is necessary:

- To comply with a legal obligation.
- To protect and defend the rights or property of Susteer.
- To prevent or investigate possible wrongdoing in connection with the Service.
- To protect the personal safety of users of the Service or the public.

### How long we keep your data for

We will retain your personal data as set out in this Privacy Policy and as required by applicable law. We may also retain certain information in order to conduct audits; comply with our legal obligations (and to demonstrate compliance) and to resolve disputes. However, we will not retain your personal data for longer than seven years from contract or contact activity unless you request we delete your data. We will then delete your data if we are legally able to do so. Should we be unable to delete your data legally we will inform you and you will then have the choice to be removed from all non-legal correspondence.

## Your information rights
